These prices are effective October 1, 2008 and are subject to change without notice. The goods and services shown within are those we provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. Our policy requires accounts to be cared for at the time of the arrangement conference. We accept personal checks, Visa, Master Card and Discover.

Prior to drafting any contract for goods and services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

# SERVICES, FACILITIES AND EQUIPMENT

**Our service charges can be significantly reduced when a burial or cremation service plan is selected. Please consult your director for details.**

- 1. ADMINISTRATIVE AND PROFESSIONAL SERVICES OF FUNERAL DIRECTOR AND STAFF** .....\$2,300.  
This is a basic fee that we charge every family for our professional service in assisting them with their preferences. It includes a proportionate share of the taxes, licenses, utilities and business expenses required to serve the public. Our charge includes but is not limited to consultation with the family, administrative and clerical services, preparation of the death certificate for certification of the attending physician or coroner, consultation with cemetery or common carrier, our availability 24 hours a day to transfer the decedent to mortuary and placement of obituary notices in newspaper and on-line at [www.oconnormortuary.com](http://www.oconnormortuary.com) as requested. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee for our basic services and overhead is already included in our charges for direct cremation, direct burial, forwarding remains and receiving remains).
- 2. TRANSFER OF DECEDENT TO O'CONNOR LAGUNA HILLS MORTUARY \* (25 mile radius)** .....\$375.  
\*Travel outside service area, excess mileage will be stated on a mileage rate chart.
- 3. PROFESSIONAL EMBALMING** .....\$400.  
Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select funeral arrangements such as a funeral with viewing or if you wish the decedent dressed for burial. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation. Embalming will be performed at O'Connor Laguna Hills Mortuary.
- 4. OTHER CARE OF THE DECEDENT** (All care of the decedent is performed at O'Connor Laguna Hills Mortuary)  
Dressing, Cosmetology and Casketing .....\$200.  
Post Autopsy or other Restorative Care .....\$250.  
Basic Sanitation (Required if no embalming).....\$225.  
Refrigeration (Required if no embalming) .....\$375.  
Custodial Care .....After 5 days, \$50. per day  
Use of Prep Room for Medical or Ceremonial Purposes (2 hour maximum).....\$350.
- 5. FACILITIES FOR VIEWING** .....\$350.  
Use of the O'Connor Laguna Hills Mortuary or outside facility, necessary equipment and staff for visitation (Includes 2 hours in morning or afternoon or evening)
- 6. FACILITIES FOR FUNERAL CEREMONY** .....\$595.  
This service includes our charge for the use of the O'Connor Laguna Hills Mortuary Chapel or outside facility, necessary equipment and staff for the conduction of services.
- 7. FACILITIES FOR MEMORIAL SERVICE** .....\$595.  
This charge includes all items listed under "Facilities for Funeral Ceremony".
- 8. CONDUCTION OF SERVICES AT CHURCH – GRAVESIDE (Same Day Included)** .....\$595.  
Includes the mortuary staff and necessary equipment for conduction of services.
- 9. GRAVESIDE SERVICE (ONLY)**.....\$495.  
Includes the mortuary staff and necessary equipment for conduction of services. Sound system available upon request and subject to availability.
- 10. WEEKEND AND HOLIDAY SERVICE FEE**  
Additional charge for Saturday, Sunday or Holiday Service.....\$350.
- 11. AUTOMOTIVE EQUIPMENT WITHIN THE LOCAL AREA\*(Each Service)**  
Hearse\* .....\$375.  
Limousine (7 passenger vehicle; includes 4 hours - additional hours - \$95. per hour).....\$375.  
(8 to 10 passenger vehicle; includes 4 hours - additional hours - \$120. per hour) .....\$475.  
Utility Vehicle:\* required for local trips to Doctor's offices, Health Department, transfer of flowers and clergy transportation.....\$200.  
\*Local Area - 25 mile radius; for additional charges for distances over 25 mile radius, see out of area mileage chart.

**The services, facilities and equipment listed above do not include cash advance items, transportation out of our service area and staff overtime, if applicable.**

# MEMORIAL PRODUCTS AND EVENT ENHANCEMENTS

**Our memorial product charges can be significantly reduced when our memorial products savings plan is utilized. Please consult your director for details.**

**CASKETS:** We offer many styles and prices of caskets from which to select. Since many caskets that seem similar in appearance may differ greatly in quality and construction, we offer the following to assist you in making an informed decision. The two basic types of caskets are:

**Protective:** These caskets are designed by the manufacturer to resist the entrance of air, water and other outside elements. They may be constructed of varying gauges of steel, copper or bronze.

**Non-Protective:** These caskets are not designed by the manufacturers to resist the entrance of air, water and other outside elements. They may be constructed of hardwood or wood products covered with fabric. A complete price list will be provided at the mortuary.

The price range for traditional adult burial and cremation caskets is .....\$825. to \$10,795.

# Cremation Options

For those families which prefer cremation, O'Connor Laguna Hills Mortuary was remodeled in 1990 to accommodate a crematory. O'CONNOR LAGUNA HILLS CREMATORY is a privately-owned crematory and is not associated with any "Memorial Society." It is reserved only for those families we serve and each cremation is performed on an individual basis. Whether you select a simple cremation, full services or viewing followed by cremation or a cremation with a memorial service in our chapel at O'Connor Laguna Hills Mortuary or an outside facility or location, our directors will provide you with the cremation options to personalize the service. Please consult your director or refer to the cremation service plans for your options. We also offer witness cremation and witness processing so your family can have the opportunity of a final goodbye.

**DIRECT CREMATION** .....\$2,050. to \$2,125.

Includes adjusted administrative and professional services of the funeral director and staff, transfer of remains to O'Connor Laguna Hills Mortuary, refrigeration, use of our crematory for cremation, processing and packaging of cremated remains. This charge does not include merchandise, viewing of remains, funeral ceremony, embalming or cash advance items. Additional charges may be added for storage of cremated remains.

If you want to arrange a direct cremation you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard, or composite materials (with or without an outside covering). The containers we provide are cardboard and fiberboard.

DIRECT CREMATION with container provided by family .....\$2,050.  
DIRECT CREMATION with cardboard container purchased from mortuary .....\$2,125.  
DIRECT CREMATION with container or casket purchased from mortuary .....\$2,050.  
(Cost of Casket or Container is extra.)

# Minimum Care Charges

**FORWARDING REMAINS TO ANOTHER MORTUARY** .....\$3,000.

Includes adjusted administrative and professional services of the funeral director and staff, transfer of remains to the mortuary, embalming, dressing, cosmetics, casketing and transportation to Orange County Airport. This charge does not include merchandise, viewing of remains, funeral ceremony, post autopsy care or cash advance items. (Airfare Extra)

**FORWARDING OUTSIDE THE UNITED STATES**.....\$450.

Due to coordinating and filing the required paperwork with embassies and consulates, there is an additional service charge for this type of arrangement. This charge does include our staff and procurement vehicle. In some instances, there are extraordinary requirements where additional charges may be added. This charge does not include the consulate and/or other governmental required cash advance fees for the transfer.

**RECEIVING REMAINS FROM ANOTHER MORTUARY** .....\$2,100.

Includes adjusted administrative and professional services of the funeral director and staff and removal of remains from Orange County airport. This charge does not include merchandise, viewing of remains, funeral ceremony, automotive equipment for services, embalming, cremation charges, other care of decedent or cash advance items.

**DIRECT BURIAL** .....\$3,000.

Includes adjusted administrative and professional services of the funeral director and staff, transfer of remains to the mortuary, preparation of remains for burial (post autopsy care extra) and use of hearse for delivery only to local cemetery at mortuary's convenience. This charge does not include casket and other merchandise, viewing of remains, funeral ceremony or cash advance items.

DIRECT BURIAL with casket purchased from mortuary or provided by family .....\$3,000.  
DIRECT BURIAL using Minimum Grey Flannel Flat Top Casket .....\$3,825.
